SUBJECT: Solicitation HT001521R0030 - Notice of Potential Organizational Conflicts of Interest (OCI)

1. The purpose of this notice is to identify companies that are ineligible to participate in teaming arrangements for Military Health System Enterprise Information Technology (MHS IT) requirements, including the subject MHS EITS Geographic Service Provider (GSP) requirement, due to Organizational Conflicts of Interest (OCI). Further instructions will be provided to offerors in the solicitation.

2. EITSI BPA OCI CLAUSE. The MHS Enterprise IT Services Integrator (EITSI) Blanket Purchase Agreement (BPA) was awarded to a contractor team consisting of Perspecta Enterprise Solutions LLC and Capgemini Government Solutions LLC (BPA Holder). Pursuant to the EITSI OCI clause, the BPA Holder and any of its owners, partners, affiliates, team members, and major subcontractors will be INELIGIBLE to perform as contractor, subcontractor, or team member on any of the MHS IT Service Provider work for the duration of the BPA and for 18 months after the final day of performance under the BPA or any Call Orders thereunder. Further, the BPA Holder and any of its owners, partners, subsidiaries, affiliates, team members, and any subcontractors will be ineligible to perform as contractor, subcontractor, or team member on a MHS IT requirement if the BPA Holder assisted with the development of the requirement or will have a role in coordination, management, or oversight of performance of the requirement.

3. The BPA Holder and its major subcontractors are:

- a. Perspecta Enterprise Solutions LLC (Prime Lead);
- b. Capgemini Government Solutions LLC (Prime Teammate);
- c. Guidehouse LLP (Major Subcontractor); and
- d. Tenacity Solutions (Major Subcontractor).

At this time, the EITSI BPA Holder has not expressly identified any other subcontractors to DHA. However, the same OCI clause would apply to any subcontractor performing work under the EITSI BPA.

4. Additionally, the following companies are providing acquisition support services to DHA and therefore are precluded from participating in teaming arrangements for MHS IT requirements:

- a. Amyx Inc;
- b. TDC Consulting LLC; and
- c. ZYGOS Consulting LLC

5. DHA encourages prospective offerors to ask questions regarding any concerns of potential personal or organizational conflicts of interest. The instructions for submitting questions regarding conflicts of interests or anything related to this acquisition will be specified in a notice under this solicitation number.
